Subject: Online portal for availing exemptions/facilities by CWSN students in Board Examinations 2026 - reg.

Madam/Sir,

CWSN students appearing for Class X/XII examinations are extended several facilities by the CBSE as per its circular No.CBSE/COORD/112233/2019, dated 12, April 2019. The circular is available on the link:

If the CWSN students desire to avail any facilities/exemptions extended by CBSE during the examinations, the request for the same can be made by the concerned school through a designated CWSN web portal. This web portal is available along with the LOC as already mentioned in the LOC notification dated 27.08.2025. The circular is available on the link:

A detailed SOP regarding the same is attached with this circular for ready reference of all schools for all such candidates; the schools should mark candidates as CWSN in the LOC and mention their disability.

The schools should log-in to **Pariksha Sangam portal** using their login ID and password where in the CWSN module, they will be shown the list of the candidates who have marked as CWSN in the individual LOC data and the facilities permissible to each category of students as per their disability. If the students wish to avail any of the facilities, the same is to be selected by the school so that details would be automatically made available in the admit card itself. The examination centers can accordingly make the necessary arrangement for all such candidates causing no inconvenience to any candidate with special needs.

It is therefore requested that if any CWSN students wish to avail the facilities extended, the school should fill the details and upload the requisite documents on the portal, which is made available parallel to the LOC portal as per schedule given below:-

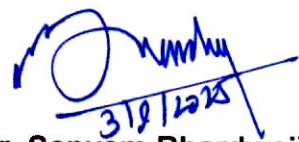

You are aware that CBSE will hold two examinations in Class X in 2026. Thus, following all such instructions issued by the CBSE and strictly adhering to the schedule for smooth conduct of examinations is a must.

No request of any sort will be catered to after the schedule mentioned and in offline mode. Hence, schools are directed to strictly adhere to the schedule given.

The SOP (Standard Operating Procedure) for making request is annexed with this circular for schools to read it carefully and follow the process. The schedule will not be extended and no candidate will be allowed to be added as CWSN once this schedule is over.

Hence, all schools should complete the process with due diligence within the stipulated schedule.

USER MANUAL



OVERVIEW

The Central Board of Secondary Education (CBSE) being sensitive to the needs of disabled students is extending several exemptions/concessions to candidates with disabilities as defined in The Rights of Persons with Disabilities Act - 2016.

It has been observed that neither the schools nor the students are fully aware about these exemptions and are also not following correct way of seeking available exemptions during their course of studies and examinations.

It has therefore, been decided made the portal for CWSN Management System to update and compile all exemptions/concessions so that schools are aware about the same.

In addition to extra time, scribe or reader, computer or laptop (without internet) we had also allowed use of basic calculators for candidates registered under CWSN category.

Steps to operate CWSN MANAGEMENT Portal for updating the facilities offered to CWSN candidates :-

1. School have to login by using LOC User-Id and password, and then type the captcha given on the screen and submit.

2. After Login into the CWSN management system, the school needs to choose the facilities available for different categories of CWSN candidates. On home page, firstly School has to click on **CWSN details tab**. After Choosing the **Class (X/XII)**, clicking any one option from **Pending / Updated / All**.

- a. On selecting the option **All** and pressing **GET LIST** button, the screen will display the details of all the Candidates of School registered under CWSN category for Class(X/XII).



- b. On selecting the option **Pending** and pressing **GET LIST** button, the screen will display the details of the Candidates of the School who are registered under CWSN categories for Class(X/XII) but the facilities offered has not been yet opted for. This is only one time option and no updation/correction is allowed further, so you have to select the option very carefully. Now click on the checkbox available against the facility for respective CWSN category of the student and also upload the supporting disability document (in pdf format and Max Size 2 MB). After this, click on the save button. The data / facility opted has been saved for the candidate. The same process is to be repeated for all the candidates registered under CWSN categories.

5. After step-4, School has to click on **Finalized CWSN Data**. After clicking, the School needs to select the **Class (X/XII)** and press **GET LIST** button. It will display the finalized list and status of data in **Status/Remark** column. If the case is Approved / Rejected from Regional Officer, it will shows as Approved or Reject otherwise under process.
